1 Appearance

There are two types of camera and the appearances are shown below.




Figure 1-1 Overview of Type I Camera




Figure 1-2 Overview of Type II Camera

Note:

Press RESET about 10 s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC or PoE (802.3af). Make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Disassembling

Purpose:

The installation steps of type I and type II are similar and here takes type I as an example to describe the steps. Before mounting, you have to disassemble the camera and install the memory card first.

Steps:

1. Loosen the screws to remove the bubble and the black liner.

2.2 Memory Card Installation

Steps:

- Rotate the camera body to completely expose the memory card slot.
- Insert the memory card into the memory card slot, and push to get it mounted.




Figure 2-2 Install the Memory Card

3. (Optional) To unmount the memory card, push to eject it.

2.3 Ceiling Mounting

Steps:

- Paste the drill template to the place where you want to install the camera.
- Drill screw holes and cable hole (optional) in the ceiling according to the drill template.




Figure 2-3 The Drill Template

Note:

If you need to route cables through the ceiling, dill a cable hole according to the drill template. Skip this step if you want to route the cables on the surface of the ceiling.

- 3. Route the cables of the camera.
- 4. Align the holes and secure the camera with the screws.

Note:

- The supplied screw package contains self-tapping screws, and expansion bolts.
- For cement ceiling, use expansion bolts to secure the camera. For wooden ceiling, use self-tapping screws
- Connect the corresponding cables, such as power cord and network cable.
- 6. Power on the camera, and set the network configuration (for details, refer to 3 Setting the Network Camera over the LAN and 4 Accessing via Web Browser) to check whether the image is gotten from the optimum angle. If not, adjust the surveillance angle (for details, refer to 2.4.1 Angle Adjustment).
- 7. Install the inner black liner back to the camera.
- 8. Install the bubble back to the camera and secure it with screws.




Figure 2-5 Secure Black Liner and Bubble

2.4 Image and Focus Adjusting

Before you start:

Connect the video out interface of the camera to a monitor for image and focus adjustment.

2.4.1 Angle Adjustment

Steps:

1. View the camera image by using the monitor.

 Loosen the tilt adjusting screw to adjust the tilt angle from 0° to 75°, hold the black liner to adjust the pan angle from 0° to 355°.




Figure 2-7 Angle Adjustment

2.4.2 Zoom and Focus Adjustment

Manually Adjustment

Certain camera models of this series have the lens that zoom and focus levels must be manually adjusted via zoom/focus lever and you can use zoom lever and focus lever to adjust the lens.

Steps:

- 1. View the camera image by using the monitor.
- Loosen the zoom lever and move the lever between T (Tele) and W (Wide) to obtain the appropriate angle of view.

- 3. Tighten the zoom lever.
- Loosen the focus lever and move the lever between F (Far) and N (Near) to obtain the optimum focus.
- 5. Tighten the focus lever.

Motor-driven Lens

Certain camera models of this series are equipped with a motor-driven lens. You can adjust the zoom and focus level on PTZ control panel by visiting the camera via web browser or client software.




Figure 2-9 Zoom and Focus Adjustment via Web Browser

3 Setting the Network Camera over the LAN

Note:

You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection.

If the product does not work properly, contact your dealer or the nearest service center for help.

3.1 Wiring

Connect the camera to network according to the following figures.




Figure 3-2 Connecting via a Switch or a Router

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for Activation via Client Software

3.2.1 Activation via Web Browser

Steps:

- Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address

Create a password and input the password into the password field.



STRONG PASSWORD RECOMMENDED— We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

- 4. Confirm the password.
- 5. Click OK to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

Steps:

- 1. Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device.




Figure 3-4 SADP Interface

Note:

The SADP software supports activating the camera in batch. Refer to the user manual of SADP software for details.

Create and input the new password in the password field, and confirm the password.

And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

Note:

You can enable the Guarding Vision service for the device during activation. Refer to Chapter 5.1 for detailed information.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an activate device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

Note:

You can enable the Guarding Vision service for the device during activation. Refer to Chapter 5.1 for detailed information.

 Input the admin password and click Modify to activate your IP address modification.

The batch IP address modification is supported by the SADP. Please refer to the User Manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

Install the plug-in before viewing the live video and managing the camera. Please follow the installation prompts to install the plug-in.

Note:

You may have to close the web browser to finish the installation of the plug-in.

Reopen the web browser after the installation of the plug-in and repeat steps 2 to 4 to login.

Note:

For detailed instructions of further configuration, please refer to the user manual of network camera

5 Operating via Guarding Vision App

Purpose:

Guarding Vision is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Guarding Vision service is not supported by certain camera models.

5.1 Enable Guarding Vision Service on Camera

Purpose:

Guarding Vision service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Guarding Vision Service via SADP Software Steps:

- 1. Check the checkbox of Enable Guarding Vision on:
 - "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.

Note:

The verification code is required when you add the camera to Guarding Vision app.

- 3. Click and read "Terms of Service" and "Privacy Policy".
- 4. Confirm the settings.

5.1.2 Enable Guarding Vision Service via Web Browser Before you start:

You need to activate the camera before enabling the service. Refer to Chapter 3.2.

Steps:

- 1. Access the camera through web browser. Refer to Chapter 4.
- Enter platform access configuration interface: Configuration > Network > Advanced Settings > Platform Access

- 3. Select Platform Access Mode as Guarding Vision.
- 4 Check the checkbox of Enable
- Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- 6. Create a verification code or change the verification code for the camera

Note:

The verification code is required when you add the camera to Guarding Vision app.

7. Save the settings.

5.2 Guarding Vision Setup

Steps:

- Download and install the Guarding Vision app by searching "Guarding Vision" in App Store or Google PlayTM.
- 2. Launch the app and register for a Guarding Vision user account.
- 3. Log in Guarding Vision app after registration.

5.3 Adding Camera to Guarding Vision

Before you start:

You need to enable the Guarding Vision service on camera before adding it to your Guarding Vision account. Refer to Chapter 5.1.

Steps:

 Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Guarding Vision app.

2. In the Guarding Vision app, tap "+" on the upper-right corner and then scan the OR code of the camera to add the camera.

You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the icon and inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Guarding Vision service on camera
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser
- Follow the prompts to set the network connection and add the camera to your Guarding Vision account.

Note:

For detailed information, refer to the user manual of the Guarding Vision app.

5.4 Initializing the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
